Our monitoring services are conducted monthly for the first year of performance and quarterly thereafter to maintain quality assurance and sustain successful green cleaning management.

Certification Process: From training to application submission, the steps to achieving GS-42 certification, CIMS, or points toward LEED certification can be time consuming and resource intensive. In addition to providing the 24 hours of training required under the GS-42 standard, our consulting team offers guidance through all of the necessary steps in the certification process, including:
